1.	<p><b>INTRODUCTION</b></p> <p>The Assistant Headteacher will be required to safeguard and promote the welfare of children and young people and follow school policies and the staff code of conduct</p> <p>The Assistant Headteacher will meet the general requirements of this post, and those of a class teacher, as specified in the School Teachers' Pay and Conditions Document. The post will require you to work in partnership with the Headteacher, governors and staff to ensure the continuous improvement and effective operation of the school</p> <p>Please note that this job description is illustrative of the general nature and level of responsibility of the role. It is not a comprehensive list of all tasks that the deputy headteacher will carry out. The postholder may be required to do other duties appropriate to the level of the role, as directed by the headteacher</p>		
2.	<p><b>SPECIFIC RESPONSIBILITIES:</b></p> <ul style="list-style-type: none"> <li>• Lead on the school assessment strategy (tracking, reporting and intervention) ensuring it is rigorous, well evidenced, and easy to communicate to pupils and parents.</li> <li>• Track and analyse all student performance data, paying particular attention to disadvantaged groups such as those eligible for pupil premium or with SEND.</li> <li>• Oversee, plan and implement and evaluate whole school interventions for those who are not progressing</li> <li>• Keep up to date with accepted best practice in the field of assessment.</li> <li>• Provide expert support to middle and senior leaders, teachers, and governors in interpreting and using a range of academic and pastoral datasets to raise achievement and monitor the impact of interventions.</li> <li>• Support colleagues in implementing an evidence-based approach to monitoring attendance, behaviour &amp; teaching, including our use of pupil premium &amp; catch-up funding</li> <li>• To oversee the internal &amp; external exam process (including post exam results services in August) &amp; ensure that legislation, guidance, and exam-board rules are followed</li> <li>• To oversee or lead on other data and systems-based work including MIS systems, census returns, post-16 funding returns etc. (list not exhaustive).</li> <li>• Line manager of designated teaching and support staff. and key departments</li> <li>• SLT link to a designated Year team</li> </ul>		

**The main requirements are detailed below and involve a commitment to:**

**1. SHAPING THE FUTURE**

- To support the Headteacher and governors in establishing a vision for the future development of the school
- To play a leading role in the school improvement planning process, taking account of the agreed priorities of the school
- To contribute to the identification of key areas of strength and weakness in the school and to lead in relevant areas e.g. projected staffing/timetabling and curricular changes
- To work to a high standard in implementing agreed policies and priorities, and to set high expectations and a good example for other colleagues
- To promote a culture of teamwork, in which the views of all members of the school community are valued and taken into account
- To contribute to the self-evaluation of the school

**2. LEADING LEARNING AND TEACHING**

- To provide training for staff on effective teaching and learning
- To promote the active involvement of students in their own learning
- To lead on target setting, including statutory procedures and targets for individuals and groups of students throughout the school
- To support strategies to promote high standards of behaviour
- To contribute to the development of a broad and rich curriculum that meets the needs of the range of students in the school
- To lead on the development of an effective assessment framework
- To promote the use of ICT to enhance and extend students' learning
- To monitor and evaluate classroom practice
- To provide support for colleagues in improving their classroom practice

**3. DEVELOPING SELF AND WORKING WITH OTHERS**

- To promote equal opportunities and safeguard the safety and welfare of all those in the school
- To contribute to the creation of a positive school ethos, in which every individual is treated with dignity and respect and the safety and welfare of children and young people is paramount e.g. through taking school assemblies and having an oversight of all educational off site activities
- To support the development of collaborative approaches to learning within the school and beyond
- To support the induction of staff new to the school
- To set high expectations for your own performance and that of others and to assist with the setting and monitoring of professional standards in the work of all staff members
- To engage in relevant professional development activity as necessary and to guide staff in their training and personal development

**4. MANAGING THE ORGANISATION**

- To monitor the quality of teaching and learning in the school and to promote improvement.
- To contribute to a regular review of the organisation of the school to ensure it meets statutory requirements
- To develop action plans in specified areas of responsibility, to bring about improvements
